**11B-202.4 Path of travel requirements in alterations, additions and structural repairs.** *When alterations or additions are made to existing buildings or facilities, an accessible path of travel to the specific area of alteration or addition shall be provided. The primary accessible path of travel shall include: 1) A primary entrance to the building or facility; 2) toilet and bathing facilities serving the area; 3) drinking fountains serving the area; 4) public telephones serving the area; 5) signs.*

**11B-202.4 Exception #8:**

*When the adjusted construction cost is less than or equal to the current valuation threshold, as defined in Chapter 2, Section 2 (of the California Building Code) the cost of compliance with Section 11B-202.4 shall be limited to 20 percent of the adjusted construction cost of alterations, structural repairs or additions. When the cost of full compliance with Section 11B-202.4 would exceed 20 percent, compliance shall be provided to the greatest extent possible without exceeding 20 percent.*

The adjusted construction cost shall not include the cost of alterations to path of travel elements required to comply with 11B-202.4. The 2021 valuation threshold is \$172,418.
