TRAVEL TRAILER DISMANTLING PROGRAM REQUIREMENTS

Steps:

- 1. **MANDATORY NOTIFICATION**: required at least 48 hours prior to transporting travel trailer to the Ridgecrest Landfill. Contact Kern County Waste Management Department at (661) 862-8900 to set an appointment. Upon notification, the size and condition of each travel trailer must be reported. Limit 1 per day/per customer.
- 2. Obtain a California Department of Motor Vehicles Junk Certification Form.

Individual vehicle owners can junk and/or dismantle their vehicle, by presenting the vehicle documents to the Department of Motor Vehicles. The requirements are:

The California Certificate of Title. The title must be endorsed for transfer of ownership if the vehicle is not registered in your name.

The license plates on the vehicle.

Fees are due if the vehicle record does not indicate the vehicle is currently registered or has a planned non-operation status.

Additional information can be viewed at www.dmv.ca.gov. Present the Junk Certification form to the County personnel on duty at the site.

- 3. Travel trailers contain many items that cannot be buried at municipal landfills, however arrangements can be made to facilitate proper receipt and handling. Tasks such as empting the septic and grey water tank, removing propane tank(s), and unhooking appliances are required prior to travel trailer acceptance. Please see the Travel Trailer Dismantling form for a complete list of pre-acceptance requirements.
- 4. All travel trailers delivered to the site are subject to inspection by Kern County Waste Management Department staff prior to acceptance.
- 5. Travel trailers arriving without the proper original signed paperwork or that have not been properly pre-processed will not be accepted.
- 6. The cost for services is \$100 per travel trailer plus \$45.00 per ton. Customer may pay with a check, credit card or cash. A cash deposit will be required if check or credit card payment is not available.
- 7. Travel trailers will be dismantled, recycled (if possible) and disposed. Customers cannot salvage trailer frames.
- 8. SCHEDULE: Wednesdays 11:00 a.m. Ridgecrest Sanitary Landfill
 By appointment only call (661) 862-8900, Monday–Friday.
 Appointment must be made at least 48 hours prior to disposal.
