- Your business must generate less than 220 lbs. of hazardous waste or 2.2 lbs. of extremely hazardous waste per calendar month.
- Your business must be located and the waste generated within Kern County.
- You are required to obtain an EPA ID Number. Form 1358 is available through the DTSC website (www.dtsc.ca.gov).
