
AN ORDINANCE OF THE BOARD OF SUPERVISORS  
OF THE COUNTY OF KERN, STATE OF CALIFORNIA  
ESTABLISHING THE SCHEDULE OF SOLID WASTE  
COLLECTION CHARGES IN COMMERCIAL ZONE 3  
FRANCHISE AREAS 3, 19, 38, AND 43 FOR FISCAL  
YEAR 2023-2024



THE BOARD OF SUPERVISORS OF THE COUNTY OF KERN ORDAINS AS FOLLOWS:

Section 1. This Ordinance, which shall take effect and be in full force on and after the 23<sup>rd</sup> day of June, 2023, shall have a summary published in accordance with the provisions of Government Code Section 25124(b)(1).

**Section 2.** Findings and Determinations.

1. Commercial properties are designated by the Board of Supervisors as an area where solid waste collection services are required for all properties, except vacant land or non-developed properties.
2. A written Report containing a description of commercial properties requiring solid waste collection in Commercial Zone 3 Franchise Areas 3, 19, 38 and 43 and the amount of the charge for services for Fiscal Year 2023-2024 has been prepared by the Public Works Department and filed with the Clerk of the Board of Supervisors.
3. Prior to the adoption and approval of the Report, a properly noticed hearing has been held, all objections or protests heard, considered and ruled upon.
4. At the conclusion of the hearing and concurrently with this Ordinance, the Report, including the findings and charges for service were approved and adopted by this Board.
5. This Board hereby certifies that these rates are set in full compliance with the provisions of Proposition 218.

**Section 3.** Solid Waste Collection Charges for Fiscal Year 2023-2024 for Commercial Zone 3 Franchise Areas 3, 19, 38, and 43.

1. Pursuant to Kern County Ordinance 8.28.060 and 5.36.090, the schedule of Solid Waste Collection Charges for Commercial Zone 3 Franchise Areas 3, 19, 38, and 43 for Fiscal Year 2023-2024 is hereby established as per Exhibit A.

**Section 4.** If any clause, provision, sentence, or paragraph of this Ordinance, or the application thereof, is deemed to be invalid as to any person, entity, establishment or circumstance, such invalidity shall not affect the other provisions of this Ordinance which still remain in effect, and to its end, it is hereby declared that the provisions of this Ordinance are severable.

**Section 5.** At a properly noticed Public Hearing, the Kern County Board of Supervisors (Board) may approve future rate adjustments based on the prior fiscal year Consumer Price Index (CPI) for all Urban Consumers, Garbage and Trash Collection (Series ID: CUUR0000SEHG02) without a protest hearing for five years. If, in any year, the rate adjustment approved by the Board is lower than the amount resulting from the application of the CPI, the difference may be carried over and applied by the Board to future rate adjustments. In the event the cited index is substantively changed or is no longer published, the Board will select a substantially similar index.

Section 6. The schedule of Solid Waste Collection Charges shall become effective July 1, 2023.

Section 7. This Ordinance shall supersede and replace Kern County Ordinance G-9130.
